PLEASE TAKE NOTICE that the applicant intends making an application to the above Honourable Court on a date and time to be arranged with the Registrar for an order in the following terms:


1. The National Health Insurance Act 20 of 2023 ("NHI Act") is declared to be unconstitutional and invalid and is set aside.
2. In the alternative to prayer 1, one or more of the following sections of the NHI Act are declared to be unconstitutional and invalid and are set aside:
 - 2.1. section 7(2)(f)(i);
 - 2.2. section 31(2);

- 2.3. section 33;
- 2.4. section 39(2)(c)(i);
- 2.5. section 49(2)(a)(ii); and
- 2.6. section 55.

3. In terms of section 15(1)(a) of the Superior Courts Act 10 Of 2013, read with section 172(2)(c) of the Constitution, the aforesaid declaration of constitutional invalidity is referred to the Constitutional Court for confirmation.

4. Any respondent that opposes this application is ordered to pay the costs of the application on scale C, including the costs of four counsel.

5. Granting the applicant further and/or alternative relief.
